

**Income Tax Act 1961 s 275A - Contravention of order  
made under sub-section (3) of section 132**

**Whoever contravenes any order referred to in the second  
proviso to sub-section (1) or sub-section (3) of section 132  
shall be punishable with rigorous imprisonment which may  
extend to two years and shall also be liable to fine.**
